Fixed Charge

The Fixed Charge covers many costs beyond core student tuition incurred by the School. This includes metropolitan day excursions, compulsory year level camps, functions and award ceremonies attended by students and families, ICT infrastructure, print materials, student accident insurance cover, student cards and other miscellaneous costs. The cost is averaged over a student's schooling journey and not paid in arrears. The charge is payable for each student and no allowances are made for siblings.

Parents' and Friends' Association (P&F) Subscription

The Pembroke Parents' and Friends' Association is the major parent body within the School. Its main function is to support the life of the School through activities and engagement. It acts as a central liaison with all parent groups at Pembroke. A small annual subscription fee is applied to each family account for membership of the P&F.

Fees in Advance

The School recognises that some parents may wish to pay Tuition and Boarding Fees in advance for convenience or financial planning purposes, and will accommodate such arrangements while ensuring the School's financial management practices remain consistent and transparent. Fees may be paid up to three years in advance on the basis that the fees for that period are then set. Fees for the prepaid period will be fixed at the rate applicable for the first full year of payment.

Pembroke Building Fund

The power of the Pembroke Building Fund came to the fore in 2025 with the reopening of Turner House for boarding alongside dynamic classroom upgrades and revitalised play and recreation spaces across the Sub-Schools. As we look forward to further classroom upgrades in 2026 and the highly anticipated unveiling of our new Junior School Playground and Covered Outdoor Learning Area, the Building Fund has never been more important in laying the foundations for our next chapter. By making a tax-deductible donation to the Pembroke Building Fund, you can support our bold vision for the learners of today and tomorrow. We encourage an amount of \$888 per annum (\$296 per instalment or \$88.80 per monthly direct debit). Your valued donation will be recognised under the School's Community Giving Program, with cumulative donors of \$1,000 qualifying for membership of the Pembroke School Foundation.

School Policies and Obligations

1. The fees detailed in this schedule are effective from 1 January 2026 and will remain in force until such time as changed by the School Board.
2. While it is the aim of the School Board to set fees on an annual basis, the Board reserves the right to change this at any time.
3. Those persons who have contractually agreed to pay the School's fees and charges are bound by the School's schedule of fees and charges.
4. The School requires a full term's notice in writing to be provided to the Principal before the withdrawal of a student from the Day School. Failing such notice, the applicable fee for a full term will be levied. Enrolment and re-enrolment into the Boarding House is for the full school year unless otherwise agreed. Parents accept the responsibility for the payment of the Boarding Fees for the whole of each year or the agreed lesser period for which the student is accepted into the Boarding House. Boarding enrolments will automatically renew for the following year unless notice in writing is provided to the Principal by no later than the first day of Term 4 of the preceding year. Failing such notice, annual Boarding Fees for the subsequent year will be levied.
